Therefore, although the strength of the generic may be the same as the brand name drug, how it works in the body of any given patient may vary. In most cases, generic drugs work as well as their brand name counterparts, with the added benefit of being significantly less expensive. Generic drugs are required to be bioequivalent to the brand name drug, meaning that two drugs given to the same patient in the same dosage regimen will result in equivalent concentrations of the drug in plasma and tissues.
