This patent was set to expire. Jan 3, - Because Cialis is more or less substitutable, Pfizer's brand name drug will take a hit when that goes off patent next year. It needed to do something. By limiting the license to one company, Pfizer can still control the prices somewhat and prevent competition from driving the price down dramatically. Jan 6, - As it now stands, the Cialis patent held by Eli Lilly & Company is scheduled to expire in , but no manufacturer thus far has announced its intention to market a generic copy of the medication. This could be explained by French drugmaker Sanofi's tentative plans to launch an over-the-counter formulation. Jul 24, - Generic Cialis is not yet available in the United States, but it is being sold in other countries where Eli Lilly & Company's patent on the drug has expired.
