Increases risk of bleeding. Norfluoxetine the primary active metabolite has an elimination half-life of 7 to 9 days. Patient repeats regimen with each new cycle. Maximum daily dose is 60 mg. Metabolized primarily in the liver to active metabolites. Increases serum levels of these drugs. Maintenance therapy for depression in stabilized patients not for newly diagnosed depression. Monitor patient closely for adverse effects and toxicity. Patient starts 2 weeks before menstruation and continues through the first full day of menses. Increases phenytoin levels and risk of toxicity. Maximum dose is 80 mg P.Weekly Dosing Initiate Prozac Weekly capsules 7 days after the last daily dose of PROZAC 20 mg [see Clinical Pharmacology ()]. Fluoxetine is approved for the treatment of depression in children 8 years of age and older, and for the treatment of obsessive-compulsive disorder (OCD) in children 7 years of age and older. The safety and effectiveness of fluoxetine in younger children have not been established.
