Proposition 46 on the November ballot includes just such a mandate on doctors prescribing or pharmacists dispensing Schedule II, III and IV drugs that is, drugs with at least some potential for abuse to a patient for the first time. That same year, the FDA recommends tighter warnings on drugs containing acetaminophen over liver-damage fears. The Times' Lisa Girion and Scott Glover wrote a damning series of stories about the latter, revealing that a few dozen doctors each had at least three patients who had fatally overdosed on the drugs the physicians had prescribed. Why Are We Miserable? Before writing a prescription, few emergency doctors use drug-monitoring programs to see whether patients have recently been given painkillers. Dental patients mostly uninsured or indigent are not unusual in emergency rooms. For example, doctors are often rated by their hospitals with patient-satisfaction surveys for how they treat pain. But medications that mix hydrocodone with other, less popular therapeutic substances were classified as Schedule III drugs, meaning that doctors could issue refillable prescriptions that provided half a year's worth of pills -- assuming they were taken in the prescribed dosage.
