This applies to medicines prescribed on the NHS and privately. Controlled drugs Some prescription medicines are controlled under the Misuse of Drugs legislation. If you have a prescription for a controlled drug that states the drug should be dispensed in several instalments, the first instalment must be dispensed within 28 days of the date on the prescription. Repeat prescriptions Repeat prescriptions allow the same prescription to be dispensed more than once. Choose the right service. A repeat prescription must be dispensed for the first time within six months of the date on the prescription. Enter a search term: After this, the repeat prescription can continue to be valid beyond six months, according to the directions on the prescription. Who can write a prescription? Medications that are non-controlled prescriptions (C VI) are valid for ONE year from the date they are written (Enforced by Shattuck Pharmacy policy).
