So for a few months you might receive a drug that was on the low side in the bioequivalence test, and then be switched to one on the high side of the test. The lab found that Budeprion XL released the active drug at a different rate than the brand name Wellbutrin XL. In neurology, that could be quite different, because a slight difference in blood level could mean the difference between not having seizures, and having one where a single seizure can have terrible consequences. Two studies published last year in the journal *Neurology* found that patients who switched from a brand-name product to a generic one had more seizures or higher hospitalization rates.
