Prescribers will need to prepare HCP prescriptions on hard-copy, tamper-resistant prescription forms, for patients to bring to their pharmacy. Only a 30 day supply can be written. In addition, the pharmacist is required to screen, or review, the prescription and your patient medication record prior to filling the prescription. In order to perform this screen, or drug utilization review (DUR), the pharmacist will ask you to provide some basic health information such as: your sex or gender;; age, or date of birth;.
