Branded generics of oxycodone MR are now available. These are cheaper than Oxycontin but still cost more than morphine. Use brand names for clarity when prescribing MR opioids. Mistakes have occurred in prescribing and dispensing of similar-sounding brand names of immediate release and modified release.
