With the availability of a generic brand of venlafaxine in New Zealand, PHARMAC has included both generic and originator brand in the Schedule, rather than adopting a more stringent funding decision that might have seen only generic venlafaxine fully subsidized and the originator brand partially or unsubsidized. To get approval your doctor applies to Pharmac and is given a prescribing number for you which is given to your pharmacist or written on your script. To qualify for full subsidy, two other antidepressants must have been tried before venlafaxine. Dose: Recommended starting dose is 75mg per day either in divided doses or as.
