As for weathering the storm, Glaxo is in a good situation, in some ways. They did, but it was flawed. The only hits the company will take is to its reputation, and investors will likely forgive all the next time Glaxo can push another blockbuster through its pipeline. The FDA also demanded that GlaxoSmithKline foot the bill for an in-house study to see whether Avandia increased the risk of heart attacks. The window of opportunity to punish Glaxo for marketing a drug with dangerous side effects will also have probably passed. The recommendation was soft. That means a problem with this entire class of drugs would not show up in the study. You could argue that they should have, but there was no real incentive. No one probably will. Second, the study compares two drugs of the same class. The drug has been pummeled for so long that shareholders have numbed to fluctuations in the revenue stream. Revenue has since plateaued, keeping Avandia as a money-maker for Glaxo, raking in a little over a billion dollars a year. GSK has tried to defend the drug from the attacks, but there's only so much the company can do. Even if Glaxo bowed to reality, throwing in the towel on fighting to extend the patent would probably be fodder for victims' lawsuits. No one has done that.
