I am prescribed it and my prescription is current and up to date. Here is my question..I have to take a drug test within 72 hours for my new job. Of course I don't want my potential employer to know I have an anxiety issue, or what med I take. Jun 12, - Do standard employment drug urine tests test for Xanax/Alprazolam? I know it's legal, but I also know employers are not bound by law to not prevent the hiring of employees even for legally prescribed drugs. IIRC, they could legally not hire you if you test positive for aspirin. Also, can Xanax/Alprazolam. I'm sure this question has been asked and answered before but I was looking for a more recent/current answer. Can an employer not hire me if I disclose that I am prescribed Xanax? Can they say that this will affect my job performance and I'm a liability? I know I am subject to a drug test and it may or may not. Nov 20, - I have to take a pre-employment drug screening test and have a legal prescription for Celexa (40 mg) once per day, Xanax (which I have been taking mg 4 times a day) plus I take 2 hormones (I am in menopause).
