Tier 1 labeling means that a product is formulated with physico-chemical barriers to abuse. Based on the results of these studies, Hysingla ER is recognized by the FDA as having abuse-deterrent properties that are expected to deter misuse and abuse via chewing, snorting and injection, resulting in Tier 1 and 3 abuse-deterrence labeling. Decreased Bowel Motility Hysingla ER is contraindicated in patients with gastrointestinal obstruction, including paralytic ileus. In addition, discontinuation of a concomitantly used cytochrome P 3A4 inducer may result in an increase in hydrocodone plasma concentration.
